Darton Longman and Todd In his recent book *How Jesus Became God: The Exaltation of a Jewish Preacher From Galilee* historian Bart Ehrman explores a claim that resides at the heart of the Christian faith— that Jesus of Nazareth was, and is, God. According to Ehrman, though, this is not what the earliest disciples believed, nor what Jesus claimed about himself. The first response book to this latest challenge to Christianity from Ehrman, *How God Became Jesus* features the work of five internationally recognized biblical scholars. While subjecting his claims to critical scrutiny, they offer a better, historically informed account of why the Galilean preacher from Nazareth came to be hailed as “the Lord Jesus Christ.” Namely, they contend, the exalted

place of Jesus in belief and worship is clearly evident in the earliest Christian sources, shortly following his death, and was not simply the invention of the church centuries later.

Among all the writings of Plato the *Timaeus* is the most obscure to the modern reader, and has nevertheless had the greatest influence over the ancient and mediaeval world. The *Critias* is a fragment and it was designed to be the second part of a trilogy. *Timaeus* had brought down the origin of the world to the creation of man, and the dawn of history was now to succeed the philosophy of nature. It tells us about Atlantis and *Critias* returns to this story, professing only to repeat what Solon was told by the priests. The war of which he was about to speak had occurred 9000 years ago. One of the combatants was the city of Athens, the other was the great island of Atlantis.

The Technograph Bantam Dell Publishing Group The title “New Jerusalem” is mentioned twenty times in the LDS scriptures, but

only twice in the entire Bible, both of these are in the book of Revelation. The Lord is giving the apostle John specific instructions for the branch of “the church in Sardis,” which is in modern western Turkey, telling them they will be blessed if they overcome the things of this world. Then they will be a part of the “...city of my God, which is new Jerusalem, which cometh down out of heaven from my God: and I will write upon him my new name.” (Rev. 3:12) In a later chapter, we will see that John actually saw that future event when the holy city was coming down from heaven, “And I John saw the holy city, new Jerusalem, coming down from God out of heaven, prepared as a bride adorned for her husband.” (Rev. 21:2) The other eighteen references are in the latter-day scriptures. For instance, in Book of Mormon, 3 Nephi, the Lord has just finished instituting the sacrament and then he tells the Nephites, “And behold, this people will I establish in this land, unto the fulfilling of the covenant which I made with your father Jacob; and it shall be a New Jerusalem. And the powers of heaven shall be in the midst of

this people; yea, even I will be in the midst of you. (3 Nephi 20:22) In the book of Ether, translated by Moroni, he tells us about this land of America: "And that it was the place of the New Jerusalem, which should come down out of heaven, and the holy sanctuary of the Lord." (Ether 13:3) The Jerusalem Bible Wm. B. Eerdmans Publishing According to the authors, the doctrine of inerrancy has been standard, accepted teaching for more than 1,000 years. In 1978, the famous "Chicago Statement" on inerrancy was adopted by the Evangelical Theological Society, and for decades it has been the accepted conservative evangelical doctrine of the Scriptures. However, in recent years, some prominent evangelical authors have challenged this statement in their writings. Now eminent apologist and bestselling author Norman L. Geisler, who was one of the original drafters of the "Chicago Statement," and his coauthor, William C. The circulation of books was the motor of classical civilization. However, books were both expensive and rare, and so libraries - private and public, royal and civic - played key roles in articulating intellectual life. According to Ehrman, Jesus' belief in a coming apocalypse and his expectation of an utter reversal in the world's social organization not only underscores the radicalism of his

teachings but also sheds light on both the appeal of his message to society's outcasts and the threat he posed to Jerusalem's established leadership.

Bart Ehrman explores the close relationship between the social history of early Christianity and the textual tradition of the emerging New Testament, examining how early struggles between Christian "heresy" and "orthodoxy" affected the transmission of the documents over which many of the debates were waged. He makes a crucial contribution to our understanding of the social and intellectual history of early Christianity and raises intriguing questions about the relationship of readers to their texts, especially in an age when scribes could transform the documents they reproduced.
