In chapter three, specifically chosen reading comprehension passages are given in four separate sections: intermediate (B1), upper-intermediate (B2), advanced (C1) and authentic (C2). The chapter has been reorganized and new passages are included within 67 passages in almost 30 different topics. Chapter four, Word practice covers academic, scientific, social and TOEFL, Genel Dil and ECL vocabulary. Various exercises and tests are given. Most confused and misused words are covered as well.
